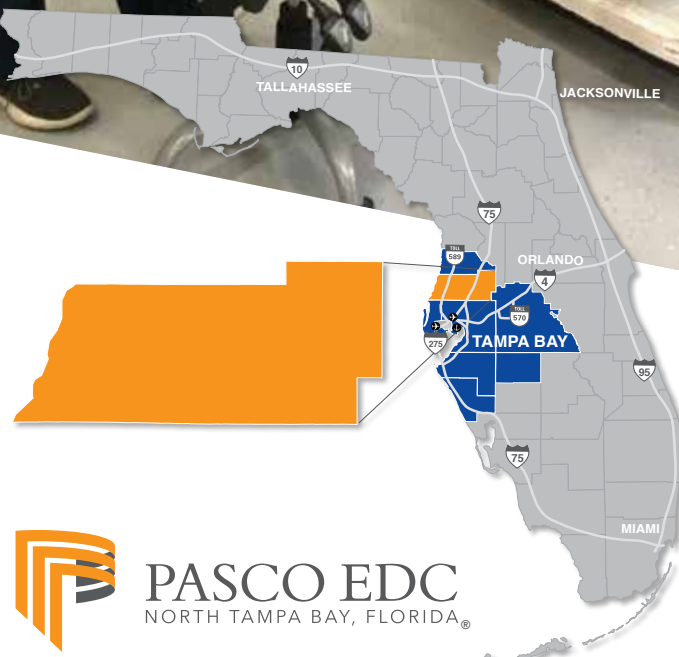

PASCO COUNTY INCENTIVES

Pasco County offers local incentives to induce Target Industries to locate and expand their businesses in the community. The Pasco EDC provides the applications and assistance to qualified projects when applying for the following Pasco County incentives:

- Job Creation Incentive (JCI) Grant
 - \$2,000-\$5,000 per job (minimum 10 new jobs)
 - Job wages at least 115% of Pasco County's average annual wage (\$40,248 current avg.)
- Transportation Mobility Impact Fee Waiver
- Ad Valorem/Tangible Tax Reimbursement

Pasco County is strategically located in the Tampa Bay region, which is home to 20% of the state's IT positions and within Florida's high-tech corridor which produces some of the country's top tech talent. Locally, we foster and develop our future workforce through two STEM high school programs and a robust talent pipeline. Our workforce along with Florida being #3 for most fiber miles among states with 61,000 total fiber miles makes Pasco the perfect location for the tech industry.

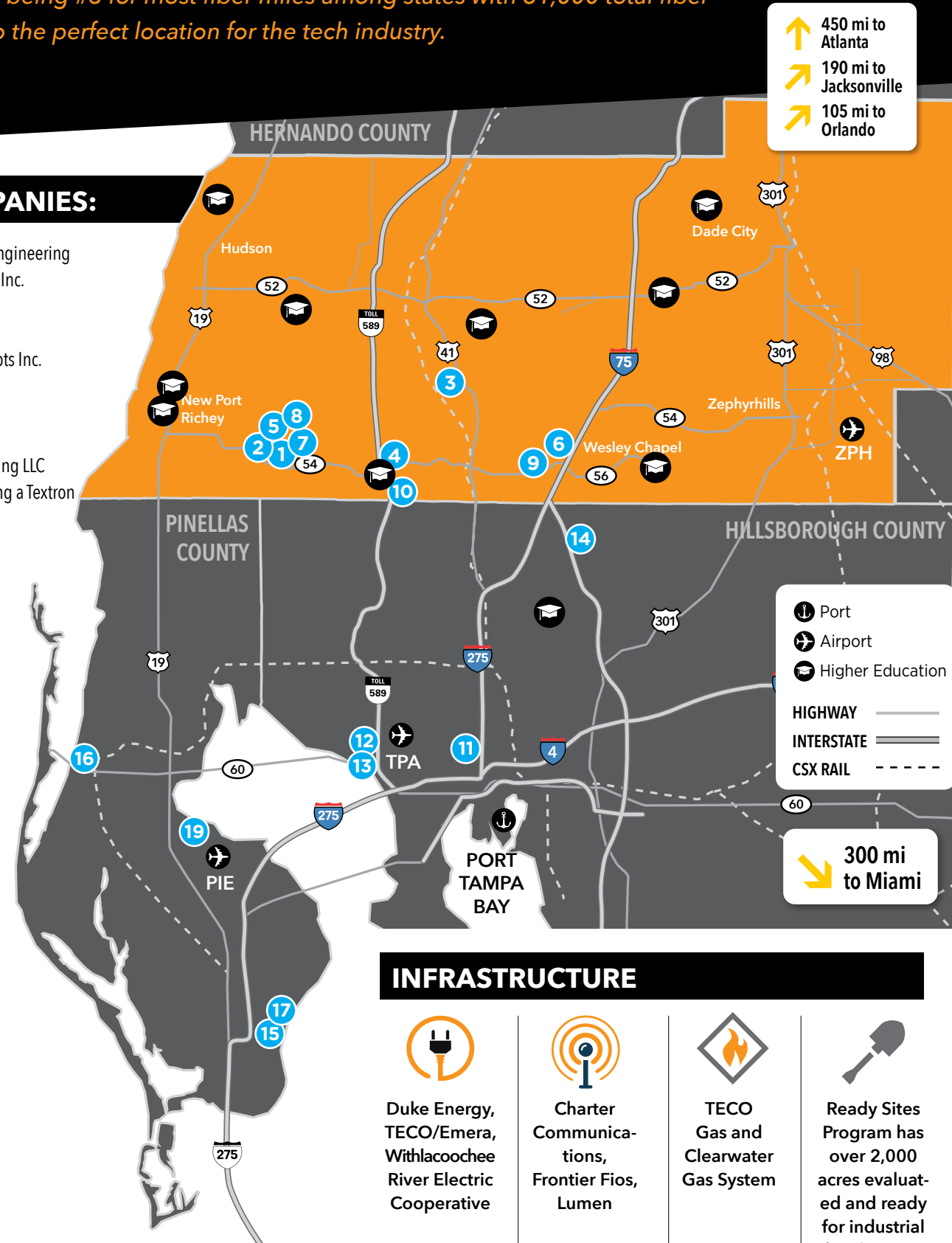

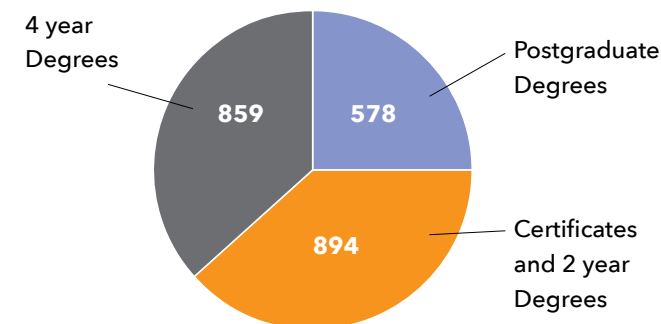

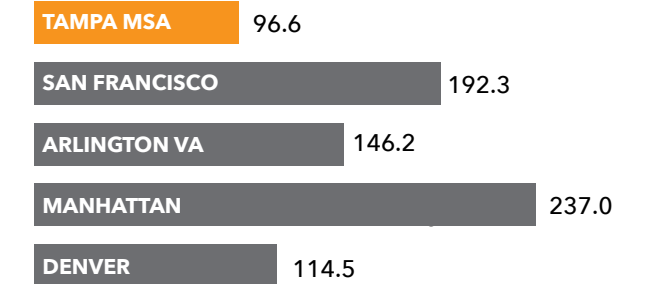
