Welcome to the 2022 Annual Report.

It's still a great day in Pasco County, Florida! It's been a great year for our business community and our residents.

Resiliency has not only become a part of our vocabulary, but it's also been interwoven into our culture. We have had yet another year of change and Pasco businesses continue to adapt and succeed in the marketplace. Our newest strategy is titled "SHAPE", as we make choices and decisions that will shape our economy in the future.

We are in great SHAPE! Pasco remains a strong location solution for our targeted industries expanding into Florida. The Pasco EDC Ready Sites program saw the first of our evaluated industrial sites sold to Amazon for a new Robotic Sortation Center.

2022 has become known as the year of the "mega-project" with large scale projects seeking thousands of acres for thousands of jobs. Pasco County is not only on the radar for these projects; we are a leading candidate. Our business development pipeline has remained strong throughout the year, and we are handling three times the amount of activity (compared to pre-pandemic levels).

And we are winning projects! 2022 was another recordbreaking year for new capital investment in Pasco County, totaling over \$242 million and over 1,260 new jobs!

2022 was also the year that inflation broke records too. Florida is no longer a "lower-cost solution" for many. However, Florida remains a "low tax solution" as we see companies making longer-term decisions based on factors like strong talent pipelines, political leadership, and

tax burdens. Why does that matter? It matters because at a time when most communities are seeking quick transactional wins, Pasco and its leaders are focused on long-term wins that will positively change our landscape and vibrancy.

In the coming year, we will reinforce our efforts in small business development and strengthening our talent pipeline.

As incubators, accelerators, and co-working spaces have become more mainstream in the Tampa Bay region, it was a surprise to many that Pasco EDC's SMARTstart program has been a leader in the start-up ecosystem for 10 years! SMARTstart and workforceCONNECT programs will be very important tools for our community in the coming months as we prepare for more change.

Lastly, we thank you, our investors and stakeholders, for your continued support. Your generosity and sponsorship broke another record last year with private investment contributions exceeding \$715,000 which removes a significant burden from our taxpayers in paying for our economic development. Speaking of which, our return on investment for public dollars in 2022 was a whopping 146:1.

BUSINESS DEVELOPMENT

The Pasco EDC utilizes a proactive approach in our business development efforts. The Business Development program encompasses recruitment of new businesses, retention and expansion of current Pasco County businesses, workforce development through WORKFORCECONNECT, an entrepreneur ecosystem through SMARTSTART, and international business initiatives with current Pasco County companies as well as recruitment efforts through Foreign Direct Investment.

The Business Development Program sets a strong foundation to actively recruit companies in our six identified target industries, presenting Pasco County as the most competitive community to locate their businesses.

READY SITES

Pasco EDC's Ready Sites Program partners with property owners to assess, evaluate and certify large tracts of industrial land to market and attract target industry projects. There are currently five (5) sites, totaling 1,860 acres, being marketed to site selectors, developers and end users through nation-wide enhanced marketing efforts. Each evaluated site has a property flyer, video, and interactive map. This year a portion of Eagle Industrial Park (63 acres) was sold to Amazon Robotics Sortation Center. Amazon will be building a 517,220 SF facility with a capital investment of \$150M, bringing 500 jobs to the county.

The Business Retention & Expansion (BRE) program is how we build and maintain relationships with Pasco County companies. Throughout the year, we visited with 66 businesses to assess current trends and identify additional needs as well as offer assistance with any future expansions.

Our retention team worked with four of our existing businesses to assist them in expanding in Pasco County (including Morganna's Alchemy, photographed above) resulting in over \$4.5 million in new capital investment. We also collected data on current challenges facing our local business community, including the increasingly tight labor market, the negative effects of a disrupted global supply chain on local manufacturers, and the increasing costs of raw materials.

Pasco 50 is a WORKFORCECONNECT semiannual event for human resource professionals throughout Pasco County to discuss workforce trends in the community. The second event took place in June at Rasmussen University. The focus was on Diversity, Equity, and Inclusion in the workplace with guest speakers Dr. Virnitia Hendricks, Executive Vice President and Chief Diversity Officer, Santander Consumer USA, and Kathy Grant, Chief Diversity, Equity, and Inclusion Officer, Moffitt Cancer Center.

The international program also connects local Pasco businesses with partners that assist develop exporting plans to bring their products overseas.

We kicked off this year with our first in-person trade mission since the pandemic! Pasco EDC organized a trade mission to Germany and Switzerland. The five-track mission gave Pasco companies an opportunity to explore business overseas and gave Pasco EDC the opportunity to market Pasco County to our international partners.

Morganna's Alchemy is a minority woman-owned business that follows a science-based and simple philosophy. They recently invested over \$30,000 in a new 2,500 square foot facility with a store front on US Highway 19, adding nine new employees to the team. In 2018 their team participated in a Global Tampa Bay Trade Mission to Chile with the Pasco EDC, and in 2020, their team participated in a U.S. Commercial Services virtual matchmaking session with China, the Pasco EDC, and our partners.



Global Tampa Bay is a regional collaboration between the Tampa Bay Economic Development Council, Pinellas County Economic Development and the Pasco Economic Development Council to increase international business opportunities for companies within the region and to market the region globally as a top business destination.

SMARTstart @ the Grove is located in Wesley Chapel, Florida. This incubator location features private office space, a conference room, classroom, and digital media studios. This year, the Grove built out an area for small businesses and created a vibrant atmosphere for the public with weekend events, live music, and more. The area is filled with shipping containers that have been converted into business spaces with air conditioning, and some with food serving capabilities. SMARTstart has a KRATE in this park which is available for incubator members to rent out for 8 hours a month as part of their membership. It can be used for pop-up marketplaces or as a classroom/meeting space. The space was designed to be interchangeable and fit the needs of what business is using it at the time.




PENNY FOR PASCO FUNDS

HIGHLIGHTS OF THIS YEAR'S FUNDRAISING EFFORTS INCLUDE:

- Private investor contributions increased by 11% totaling \$584,750 from 89 investors which represents the greatest private investment in our 35-year history.
- CareerSource Pasco Hernando sponsored Economic Forecast Luncheon for \$3,000.
- Wells Fargo donated \$15,000 and SouthState Bank donated \$5,000 to continue to seed the Microloan Program.
- Pasco County increased its base funding to \$557,670 and continues to contribute an additional \$35,000 toward the Global Tampa Bay partnership between Pasco EDC, Tampa Bay EDC, and Pinellas County EDC.
- The Pasco County Board of County Commissioners approved a cooperative funding agreement of \$2,862,000 to fund all of the Penny for Pasco programs through 2024. Pasco County continues to fund all of the Penny For Pasco programs: Ready Sites, workforceCONNECT, SMARTstart Business Incubators, Microloan, Executive Success Program, CO.STARTERS and the Pasco Enterprise Network.
