



COST OF LIVING COMPARED TO TAMPA, FL**





PASCO COUNTY INCENTIVES

PASCOUNTY FLORIDA OVINN SINCES. <u>VIENNY</u> PLACES. Pasco County offers local incentives to induce Target Industries to locate and expand their businesses in the community. The Pasco EDC assists Target Industry projects in applying for Pasco County incentives such as:

- JOB CREATION INCENTIVE (JCI)
 - Eligible companies can receive \$2,000 to \$5,000 per job with a minimum of 10 new jobs
